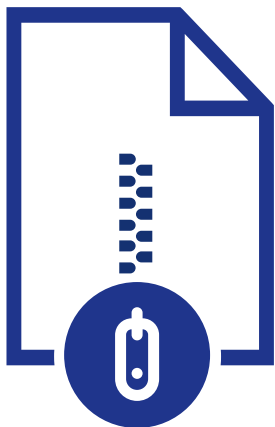

- Offers the ability to run the application silently to allow scheduling or automation from other applications



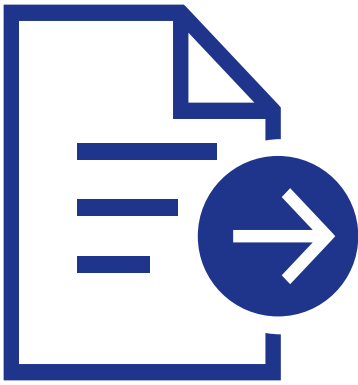
TEC Archiver for Secure Data Storage

- Offers the ability to configure an (optional) SMTP Server to email personnel upon completion

- Enables you to maintain consistency across your branded materials, with the management of house styles, document layouts and key footer information



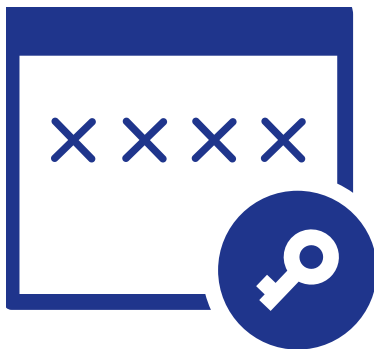
TEC Refiler for On-Demand Workspace Refiling
