The opportunity

In a very short time after the DMS went live, Peter Allinson could announce that DJB was going paperless. Lawyers are still able to print a contract to review it, but the original files are now entirely digital and secure.

Peter has identified benefits for the firm beyond the expected cost efficiencies. Importantly, the DMS enables flexible remote working, meaning that they can recruit lawyers that may have gone elsewhere. Peter says "It is now as effective to work remotely as it is to work in our office".

Risk management is improved because files can now be audited from anywhere at any time and as the regulatory environment gets tougher, this is becoming more important. Risk is also reduced by a state-of-the-art back up system.

Peter Allinson sums up the working relationship with Tiger Eye like this: "Tiger Eye are very safe hands".
